If you qualify (you submitted your city application and supplemental application), you will then be invited to the interview/swim testing at Pacific Community Pool. **The first round of swim testing is tentatively scheduled for Saturday March 1, 2025.**

Lifeguard responsibilities include general supervision of a community swimming pool or wading pool. In addition, Lifeguard I's, II's, and III's teach swim lessons and Lifeguard III's also act as senior lifeguards who can provide input regarding operations and staffing as needed. This is NOT an inclusive list of responsibilities.

Interested Applicants: Regardless of current certification status, if you are interested in working as a Lifeguard at Pacific Community Pool, please apply. **Lifeguard I applicants will be considered for hire before Hourly City Worker/Lifeguard Trainees.**

- **Lifeguard 1 applicants will have the American Red Cross Lifeguard Training certificate before employment begins in May 2025.**
- **Hourly City Worker/Lifeguard Trainee applicants will not have an American Red Cross Lifeguard Training certificate before employment begins in May 2025.**

If an Hourly City Worker/LG trainee is hired, they will go through the City of Glendale's training program which includes the American Red Cross Lifeguard Training program. Upon completion, trainees will be promoted to a Lifeguard I position. Successful completion of the city's training program is mandatory for all lifeguards, is scheduled before summer operations begin and must be completed prior to being placed on the staff schedule.

If your application is accepted and you are offered a position, YOU WILL RECEIVE AN EMAIL requesting that you to fill out and submit a conviction history questionnaire form. This questionnaire is due within 3 days of when you receive the email. If you do not follow through on submitting this in the time allotted, you may lose the opportunity to be hired as a city employee.
